YOUR WINCHESTER TOWN GOVERNMENT

The town of Winchester, Connecticut operates under a Home Rule Charter. The Board of Selectmen determines policy and appoints the Town Manager who administers the policy and the day to day affairs of the Town. The Annual Town Budget Meeting has the final authority to approve the budget for the Town.

THE BOARD OF SELECTMEN

The Board of Selectmen consists of seven members elected at large by the citizens of the town. Selectmen serve a term of two years. The Mayor is chosen by the Selectmen and serves as their Chairman presiding over the meetings and performing other duties consistent with the office. The Mayor receives yearly compensation of \$1,500. and the other Selectmen receive compensation of \$1,000.

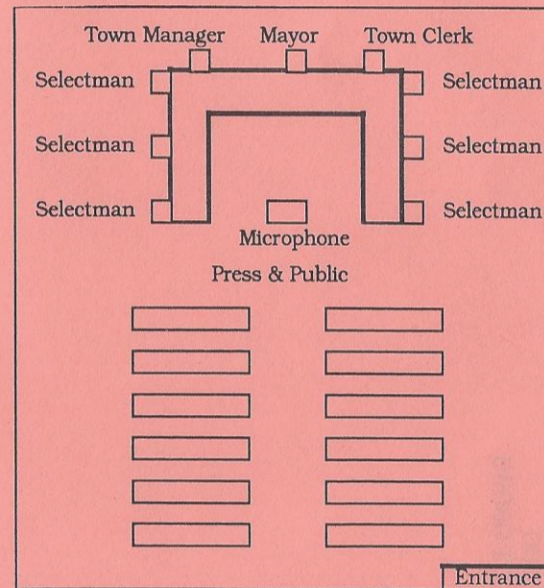
INFORMATION ABOUT MEETINGS

Selectmen meet regularly on the first and third Mondays of each month at 7:00 p.m. in the Town Hall Courtroom. An Agenda is prepared for each meeting and is available in the Town Clerk's Office at least 24 hours before the meeting.

Minutes of each meeting are taken by the Town Clerk and are available within 7 days of the meeting. Votes upon any issue are available within 48 hours of the meeting.

All meetings of the Selectmen are open to the public. Meetings may be closed for Executive Session in a few, specific, limited cases.

PUBLIC COMMENT PERIOD

Public comment is usually scheduled for 7:00 p.m. Anyone may speak during the public comment period. The board may limit the time allowed if the comments are lengthy. Some of the topics which have been raised in the public comment period are requests for street lights, comments about particular departments, suggestions about needed repairs or other things the town should do. Almost any topic dealing with local government is in order at the public comment period.

You should state your name when you begin to speak. A microphone is provided so that everyone can hear your comments.
